INTRODUCTION

The following terms and conditions (collectively the "Program Rules") govern your participation in the Celebrity Cruises Inc. MyCruiseSM REWARDS Program (the "Program") and include information describing how MyCruiseSM Points can be earned by using your cobranded Visa[®] credit card issued by FIA Card Services, N.A. (which bears the name and/or logo of Celebrity Cruises Inc. ("Celebrity Cruises"), Royal Caribbean International ("Royal Caribbean") or Azamara Club Cruises ("Azamara"), all brands of Royal Caribbean Cruises Ltd., (hereinafter the "Card"), how to redeem the MyCruise Points you earned and other important program conditions and limitations. Please read this document carefully and keep it in a safe place. As used herein, "Cardholder," "Participant," "you," and "your" refer to the applicant and co-applicant, if any, who are approved for the Card.

The Card is issued and administered solely by FIA Card Services, N.A. The terms and conditions contained in the credit card agreement provided with the Card (the "Credit Card Agreement") do not govern or apply to the Program. Any disputes concerning MyCruise Points will not affect your payment obligation to FIA Card Services, N.A. (referred to as "our", "us", or "we") on your Card account. Any use of your Card or participation in the Program constitutes your acceptance and agreement to abide by these and any subsequently issued Program Rules.

The various rewards available through the Program are the sole obligation of the provider of the applicable service or product, either Celebrity Cruises, Royal Caribbean, Azamara or a participating reward partner ("Partner"). All MyCruise Points are offered by Celebrity Cruises Inc. and are not an obligation of FIA Card Services, N.A. The Program is managed by FIA Card Services, N.A., in association with Celebrity Cruises Inc. FIA Card Services, N.A., is solely responsible for the maintenance of Program accounts, the issuance of Program statements, and the redemption of reward points through electronic fulfillment at CelebrityCruises.com/MyCruiseRewardsOnline (the "MyCruise Reward redemption(s)").

MyCruise Points are redeemable only in the form of electronic fulfillment through CelebrityCruises.com/MyCruiseRewardsOnline.

There are limits on the number of MyCruise Points that can be earned. See paragraph 8 for details. Go online to CelebrityCruises.com/MyCruiseRewardsOnline to obtain Rewards such as: onboard amenities, onboard credits, selected merchandise, discounts against the purchase price of any eligible Celebrity Cruises, Royal Caribbean or Azamara cruise vacations, stateroom accommodation upgrades, and cruise vacations on eligible Celebrity Cruises, Royal Caribbean or Azamara cruise vacations (the "Reward(s)").

RESERVE THE RIGHT FROM TIME TO TIME, AND WITH OR WITHOUT NOTICE, ADD, MODIFY, DELETE OR OTHERWISE CHANGE (COLLECTIVELY "CHANGES") ANY ASPECT OF THE PROGRAM INCLUDING, BUT NOT LIMITED TO, THE FOLLOWING: AMENDING THE PROGRAM RULES, CHANGING THE RESTRICTIONS, BENEFITS OR FEATURES, IN WHOLE OR IN PART, APPLICABLE TO THE PROGRAM; DISCONTINUING OR REPLACING ANY REWARD WITH ANOTHER OF LESSER, EQUAL OR GREATER VALUE; OR MODIFYING, DELETING OR TERMINATING ANY OR ALL OF THE PROGRAM, REWARDS, BENEFITS OR SPECIAL FEATURES OR THE TERMS AND CONDITIONS ASSOCIATED THERE WITH. MyCRUISE REWARDS PROGRAM

ELIGIBILITY

1. Cardholders will be automatically enrolled in the Program at no additional cost. However, to be eligible to participate in the Program, your Card must be open and have active charging privileges. This Program is not available to Corporate Card, Business Card, Purchasing Card accounts or accounts that participate in other Celebrity Cruises, Royal Caribbean or Azamara reward programs or co-branded card programs of any kind. Groups, conventions, corporations, partnerships, and other entities may not participate in the Program.
2. Any Cardholder(s) may be disqualified from participation in the Program if (a) in the judgment of FIA Card Services, N.A. and/or Celebrity Cruises Inc., the Cardholder(s) has violated any of the Program Rules then in effect; or (b) in the judgment of FIA Card Services, N.A., the Cardholder(s) has violated any of the terms and conditions of the Credit Card Agreement then in effect. Disqualification may result, at the sole discretion of Celebrity Cruises, in termination of the Cardholder's participation; termination of the participation of others with the same account, including authorized user(s), if any; and/or loss of unused MyCruise Points.

EARN MyCRUISE POINTS

3. You will qualify for 10,000 one-time new Cardholder Bonus Points in addition to your basic Points, if any, if you make any purchase, balance transfer, or cash advance transaction with your Card no later than 65 days after the account is first opened by us. Bonus Points are credited to your account approximately 6-8 weeks after you qualify and they will count towards your maximum Yearly Points earnings limits.
4. Cardholders earn MyCruise Points based on the volume of new net retail purchase transactions (i.e., purchases less credits, returns and adjustments) charged to the Card during each periodic billing cycle (the "Month") by the Participant(s) ("Net Purchase(s)"). There are two earnings rates. You earn one (1) MyCruise Point for every one U.S. dollar (US \$1) in Net Purchases made with the Card anywhere it is accepted. You earn a total of two (2) MyCruise Points (consisting of one base MyCruise Point and one bonus MyCruise Point) (double MyCruise Points) for every one U.S. dollar (US \$1) in Net Purchases made with the Card in connection with products or services obtained through Celebrity Cruises, Royal Caribbean and Azamara ("Cruise Products"). For any transaction to qualify for the latter rate, a Celebrity Cruises, Royal Caribbean or Azamara ship name or Celebrity Cruises, Royal Caribbean or Azamara must be identified as the merchant and appear as such on the periodic billing cycle statement (the "Statement") sent to you by us. MyCruise Points are calculated at each transaction, and are subject to verification. Fractions of MyCruise Points greater than .50 are rounded up and less than or equal to .50 are rounded down. You will earn MyCruise Points when you purchase your Celebrity Cruises, Royal Caribbean or Azamara cruise arrangements using the Card; however, the value of any MyCruise Points which may be used toward the purchase of cruise arrangements are ineligible for MyCruise Points earnings. MyCruise Points are credited to your account approximately 6-8 weeks after qualifying transactions are posted.
5. Cardholders will receive a companion airline certificate which will allow the cardholder to purchase two tickets at a discounted price. The certificate is issued upon approval of a new account and on each anniversary thereafter. 14-day advance purchase required. Fares subject to change without notice. Selection of airline varies by market. Airline service is not available in all markets. The discounted companion ticket is only available for travel in the continental U.S on fares offered through Promotions in Travel LTD. Normal taxes and fees charged by the airline will apply to both tickets. See complete terms and conditions sent with registration form. Additional restrictions may apply. Federal law prohibits students from receiving a premium.

Cardholders in good standing will receive the following additional program benefits:

Specialty Dining offer

Buy one cover charge at one of our specialty onboard restaurants at the regular price and get the second cover charge at half price. Discount applies to restaurant cover charge only; all other charges will not be included in the discount. The offer can be redeemed once per voyage, unlimited times per year. Reservations are subject to space availability and are assigned on a first-come first-served basis. This offer cannot be combined with any other discounts or offers for Specialty Dining. This benefit is not transferable and has no cash value. Must be booked using the Premium Celebrity Cruises Visa Credit Card.

10% Discount on Private Journeys

Must be booked 30 days prior to sailing by calling the Captain's Club at 1-800-760-0654. 10% Discount will be applied to the Private Journey reservation at time of booking. Additional purchases made while on your Private Journey will not qualify for the 10% discount. Discount is applicable up to four (4) people on the same tour. No refunds or changes to the booked Private Journey within one week of your sail date. Can be applied to an unlimited number of Private Journeys per voyage, unlimited times per year. This benefit is not transferable, has no cash value, and cannot be combined with any other discounts or offers for Private Journeys. Must be booked using the Premium Celebrity Cruises Visa Credit Card and is only valid on Celebrity Cruises.

10% Discount on Premium Beverage Packages

Offer is valid for alcoholic and non-alcoholic premium packages, and for all individuals in your stateroom, unlimited times per year. This benefit is not transferable, has no cash value, and cannot be combined with any other discounts or offers for Beverage Packages. Must be booked using the Premium Celebrity Cruises Visa Credit Card and is only valid on Celebrity Cruises. For complete package details visit celebritycruises.com/beveragepackages.

Future Cruise Discount

Cardholders will receive a one-time \$300 cruise discount towards a future Celebrity Cruise (7 nights or greater and in a Concierge Class stateroom or above) when you use your new credit card account to make transactions totaling at least \$5,000 (exclusive of any transaction fees, returns and adjustments) that post to your account within 60 days of the account open date. Applicable to all price programs except Interline, Travel Agent Reduced rate, Individual & Group Incentive, Employee, and net rates. Applicable to individual & group bookings to cruise component only. Not applicable for: shore excursions, tour packages, or any other personal charges. One certificate per booking, and valid only for the Cardholder noted. If credit is applied to a booking of lesser value, the difference will not be carried to another booking and it will be considered as used. Discount will have an 18 month expiration date from date of issue and cruise must be taken before expiration and is not redeemable for inaugural or holiday sailings, Celebrity Xpedition sailings or Transatlantic and Transpacific sailings. As are all requests for reservations, the offered space is subject to availability, and from time to time, itineraries may be altered or services on a specific ship may be discontinued. Cruise discount is non-transferable and may not be redeemed for cash. Discount can be used in conjunction with coupons and promotions. Certain restrictions apply. This one-time promotion is limited to new customers opening an account in response to this offer. Other advertised promotional bonus points offers can vary from this promotion and may not be substituted. You will be eligible for this benefit approximately 4-6 weeks from the date the threshold is met. Upon which, you will be able to apply this to your booking by calling the Loyalty Desk at 1-800-760-0654. The value of this reward may constitute taxable income to you. You may be issued an Internal Revenue Service Form 1099 (or other appropriate form) that reflects the value of such reward. Please consult your tax advisor, as neither Bank of America, its affiliates, nor their employees provide tax advice.

10,000 anniversary points

10,000 MyCruise points will be posted to your account when you spend a minimum of \$10,000 in Net Purchases within the anniversary year with your Celebrity Cruises Visa Card.

6. Balance transfers, cash advances, purchases of cash equivalents (including purchases of casino gaming chips), fees, interest charges, and fraudulent transactions do not earn MyCruise Points. This program is not eligible for the Preferred Rewards program.
7. Credits, returns, and adjustments do not earn MyCruise Points. Any credits, except payments made to your account, will reduce the number of MyCruise Points available for Reward selection. If credits, returns, or adjustments posting to your account should exceed purchase transactions, your Statement will report negative MyCruise Points.
8. Each Calendar Year, you may earn a maximum of five hundred forty thousand (540,000) MyCruise Points on qualifying transactions posting from January 1st through December 31st.
9. For new Cardholders, accrual of MyCruise Points may begin on the date we mail the Card and the Credit Card Agreement to you. If you are our Customer and your account is converted to the Program, you may not earn MyCruise Points until the first day of the Month beginning after you receive your Card(s). No retroactive MyCruise Points will be awarded.
10. From time to time, special offers may provide additional opportunities to earn MyCruise Points. Details will be provided when each such offer is made.
11. MyCruise Points accrued during any Billing Cycle in which the account is two cycles or greater past due at the end of the Billing Cycle will not be awarded.

EXPIRATION AND CANCELLATION OF MyCRUISE POINTS

12. MyCruise Points accumulate for a maximum of sixty (60) Months from when they are first posted to the account (the Posting Date is not the same as the Transaction Date.) This means that over the course of those 60 months (approximately 5 years), you may accumulate and redeem a maximum of two million seven hundred thousand (2,700,000) MyCruise Points.
13. After the sixtieth (60th) Month, unused MyCruise Points earned during the first Month will expire and will be subtracted from the cumulative MyCruise Points total. MyCruise Points earned from the sixty-first (61st) Month will then be added to the cumulative MyCruise Points total, and so on for each successive Month. MyCruise Points are not considered earned and available for use until they appear on a Statement. Because MyCruise Points are non-negotiable they have no cash or monetary value and may not be used to pay off or pay down any credit card balance.
14. If the Cardholder closes the account, or if we close the account, any unused MyCruise Points will be immediately forfeited unless specifically authorized by us.

15. Should you choose to close your Card, any unused MyCruise Points, which are insufficient in number to qualify for a Reward, shall be forfeited. Any request to redeem MyCruise Points sufficient in number to qualify for a Reward must be received by us before notice of withdrawal from the Program is made. The closing of your Account will not affect any Reward Coupons or Rewards provided to you prior to such closing. Should Celebrity Cruises Inc. terminate the Program, all unused MyCruise Points shall expire as provided in Paragraph 34.
16. This program is not eligible for the Bank of America Preferred Rewards program.

REDEMPTION OF MyCRUISE POINTS

17. MyCruise Points may be redeemed for a MyCruise Reward by logging into your account at CelebrityCruises.com/MyCruiseRewardsOnline. MyCruise Points cannot be redeemed if the account is not in good standing at the time of redemption.
18. Upon verification of your request, we will deduct the appropriate number of MyCruise Points from your total MyCruise Points earnings and a confirmation email will be sent to the email address provided. Once the MyCruise Points have been deducted from your account, those MyCruise Points cannot be restored to your account under any circumstances. Your MyCruise Reward Redemption will be sent electronically to Celebrity Cruises and will be applied to your reservation close to final payment. If you redeem after final payment, please call Celebrity Cruises at 1-800-760-0654 to ensure your MyCruise Reward Redemption is applied to your reservation. Please allow 6-8 weeks for merchandise that will be delivered to a specified address.
19. If an adjustment to your MyCruise Points total causes you to receive a Reward you were not otherwise entitled to, or if you redeem more MyCruise Points than you are entitled to, you agree you owe Celebrity Cruises Inc. the value of such excess redemption: Celebrity Cruises Inc. has the right to reduce your MyCruise Points accordingly, withhold any subsequent MyCruise Points and/or Rewards, and/or collect any amount(s) you owe, in any appropriate manner, including but not limited to, the posting of an equivalent debit in the form of a Cash Advance to your Card. In the instance when your cruise vacation travel documents have been issued, and the value of any transaction(s) forming all or part of the related MyCruise Reward redemption is either refunded, credited, or otherwise rescinded, Celebrity Cruises Inc. reserves the right to, in its sole discretion, cancel any reservations, void any travel documents, or post a debit to your Card which is equivalent to the dollar value of the invalidated MyCruise Points.
20. The Cardholder or any authorized user(s) of the Card is eligible to redeem the MyCruise Points earned through use of the Card. FIA Card Services, N.A. and Celebrity Cruises Inc. shall not be responsible in any way, or bear any liability whatsoever for disagreements between Cardholders and/or any third parties concerning the use of MyCruise Points. Should any such disagreement arise, any decision(s) made by FIA Card Services, N.A. and/or Celebrity Cruises Inc. regarding the disposition or use of MyCruise Points shall be final.
21. Each MyCruise Reward Redemption issued in connection with the termination of the Program will be honored by Celebrity Cruises, Royal Caribbean, Azamara or the applicable Partner, for one hundred and eighty (180) days from its date of issue. The procedures for redeeming a MyCruise Reward redemption are specified in the Rewards Section below or by going to CelebrityCruises.com/MyCruiseRewardsOnline (the "MyCruise Reward redemption(s)").

GENERAL TERMS AFFECTING ALL REWARDS

22. All Rewards are described in the Rewards section appearing below. All Rewards are subject to availability.
23. All Reward redemptions must occur seven (7) days prior to boarding with the exception of Charitable Donations, Royal Packet and Royal Wear items which are available for redemption when cruising on Celebrity Cruises, Royal Caribbean or Azamara.
24. Cardholders are subject to, and must comply with all terms and conditions governing the Reward as established by the entity providing the Reward, whether that entity is Celebrity Cruises, Royal Caribbean, Azamara or a Partner.
25. Any additional travel, accommodation, or other arrangements made in connection with any Reward are the sole responsibility of the Cardholder.
26. Earning of MyCruise Points and redemption of Program Rewards are subject to all applicable laws and regulations. The value of Rewards earned under this Program may constitute taxable income to you. You are responsible for all tax liability arising out of the Program. You may be issued an Internal Revenue Service Form 1099 (or other appropriate form) that reflects the value of such Rewards. Please consult your tax advisor, as neither Royal Caribbean, FIA Card Services, N.A., their affiliates, nor their employees provide tax advice.

TRANSFER OF MyCRUISE POINTS AND/OR MyCRUISE REWARD REDEMPTIONS

27. MyCruise Points may not be transferred from one Program account to any other. MyCruise Points do not constitute property of the Cardholder. MyCruise Points may not be brokered, bartered, or sold and may not be transferred upon disability, death, upon operation of law, or in connection with any domestic relations dispute and/or legal proceeding. No MyCruise Points pooling is allowed.
28. Redeemed MyCruise Reward items and any travel documents issued as a result of redeeming a MyCruise Reward may not be brokered, bartered, sold, or altered in any way. Any person(s) brokering, bartering, selling, purchasing, or altering MyCruise Points, MyCruise Reward Redemptions, or travel documents may be held responsible for payment of the applicable cost or fare as well as all damages, including, but not limited to, consequential damages, litigation and transaction costs. All brokered, bartered, sold, or altered MyCruise Reward Items or travel documents shall be considered void and may be confiscated either by or upon the direction of FIA Card Services, N.A. or Celebrity Cruises Inc.

PRIVACY

29. In order to make the Program work, information regarding activity on your Card account, including but not limited to specifics regarding the transaction(s) and the identity of the merchant, need to be shared between and among:
 - (a) Celebrity Cruises Inc., FIA Card Services, N.A., Partners and their respective parents, subsidiaries and affiliates and
 - (b) third parties with whom any of the foregoing contract in order to establish, operate, or manage the Program. Collectively the persons or entities identified in subsections (a) and (b) of the preceding sentence maybe referred to as the "Companies."
30. By participating in the Program, you consent to and authorize the Companies to share information about the Cardholder and the Card (including the Program component) as necessary to effect, administer, enforce, service or fulfill the terms of the Program. Any future privacy statement shall not supersede the Cardholder's consent and authorization or opt-out notifications or elections the Cardholder may make.
31. In addition, by participating in the Program, you consent to and authorize Celebrity Cruises Inc., and its subsidiaries and affiliates to use that information to inform you of special offers, products or services Celebrity Cruises, Royal Caribbean and Azamara believes would be of interest to you and marketing materials from third parties that have a strategic marketing relationship with the Celebrity Cruises MyCruise Rewards Program. As a participant in the Program, you have consented to receive all of the kinds of information described above. However, you will be given the opportunity to opt-out of mailings from such third parties and from e-mails from Celebrity Cruises, Royal Caribbean and Azamara.

DISPUTE RESOLUTION

32. All interpretations of the Program Rules as well as all questions or disputes regarding eligibility for the Program, the availability of any offers or Rewards, the availability of MyCruise Points or of a Cardholder's compliance with the Program Rules shall be resolved by Celebrity Cruises, Royal Caribbean, and Azamara at their sole discretion. Any interpretations of provisions of the Credit Card Agreement shall be resolved by FIA Card Services, N.A. in its sole discretion.
33. Information about the Program and MyCruise Points earnings will be reported on the Statement sent to you by us. Questions or disputes concerning MyCruise Points will be determined according to the terms of the Program Rules in effect when the subject purchase transaction posted to your Card. All discrepancies regarding MyCruise Points must be brought to our attention within six (6) months from the posting date of the transaction for which the adjustment is sought. Such discrepancies are not the same as credit card billing disputes and the specific resolution requirements that are applicable to them. Refer to your Credit Card Agreement or the annual Your Billing Rights notice for details about billing disputes. If you do not receive a Statement because your Card has not been used, you may call FIA Card Services, N.A. at 1-800-421-2110, and receive information concerning your MyCruise Points earnings. Customer Satisfaction specialists are available 24 hours a day, 7 days a week. Information about your Card will be provided only to the person(s) named on the account.
34. AS A CONDITION OF PARTICIPATING IN THIS PROGRAM, YOU AGREE THAT ANY AND ALL DISPUTES, CLAIMS OR CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS PROGRAM OR ANY REWARDS PROVIDED PURSUANT TO THIS PROGRAM, TO THE EXTENT THE SAME IS NOT WITHIN CELEBRITY CRUISES INC.'S SOLE DISCRETION AS PROVIDED IN THESE PROGRAM RULES AND IS NOT GOVERNED BY THE TERMS AND CONDITIONS ESTABLISHED BY THE PROVIDER OF THAT REWARD, SHALL BE LITIGATED, IF AT ALL, EXCLUSIVELY IN AND BEFORE A COURT LOCATED IN MIAMI, FLORIDA, U.S.A., TO THE EXCLUSION OF THE COURTS OF ANY OTHER STATE, TERRITORY OR COUNTRY. YOU HEREBY WAIVE ANY VENUE OR OTHER OBJECTION THAT YOU MAY HAVE TO ANY SUCH ACTION OR PROCEEDING BEING BROUGHT IN ANY COURT LOCATED IN MIAMI, FLORIDA.

TERMINATION OF THE PROGRAM

35. As of May 1, 2014, the Program has no predetermined termination date and may continue until such time as Celebrity Cruises, Royal Caribbean, or Azamara decides, at their sole discretion to terminate the Program. Celebrity Cruises, Royal Caribbean or Azamara may terminate the Program at any time with or without personal notice to you. Cardholders will have four (4) months from the date Celebrity Cruises, Royal Caribbean or Azamara announces the termination of the Program to redeem MyCruise Points for Rewards. In the case of termination of the Program, you may continue earning MyCruise Points for ninety (90) days from the date Celebrity Cruises, Royal Caribbean or Azamara announces the termination of the Program. Requests for redemption of MyCruise Points must be received by us within four (4) months from the date Celebrity Cruises, Royal Caribbean or Azamara announces the termination of the Program.
36. Without limiting the preceding paragraph, Celebrity Cruises, Royal Caribbean and Azamara may from time to time introduce new Rewards (either offered by Celebrity Cruises, Royal Caribbean, Azamara or by its Partners). Neither such promotional offers nor anything in these Program Rules shall be deemed to create or establish any agency, partnership, or joint venture relationship among Celebrity Cruises Inc., FIA Card Services, N.A., and any Partner.

GENERAL PROGRAM RULES

37.
