

Pre Cruise Checklist

() Verify your name on page 1 of this booklet to ensure it matches the appropriate form of identification (see the Travel Documents pages in this booklet) that you will need to present during ship check-in formalities. Contact your travel agent or our reservations department if a spelling correction is required. Please note, new documents are not required as your name will be correct on the ships' guest manifest.

Under a provision of the "Border Security Act" that was adopted by the U.S. government, Celebrity Cruises must now provide the government with key information on our guests in advance of sailing. The advance collection of this information will enable various U.S. government agencies, and the Customs and Immigration authorities of the countries our ships visit, to take appropriate measures to ensure that our guests and our ships are secure and safe. FAILURE TO PROVIDE THIS INFORMATION IN A TIMELY MANNER WILL RESULT IN DELAYED OR DENIED BOARDING

() Ensure you have all required proof of citizenship and/or travel documents appropriate to your travel itinerary as indicated in the Travel Documents pages of this booklet.

() Complete online check-in at www.celebrity.com/onlinecheckin then print your Boaring Pass, which will be collected during ship check-in formalities.

() If you are unable to check-in online, please complete the enclosed Charge Account / Cruise Ticket and Guest Information Form which will be collected during ship check-in formalities.

() Attach the enclosed ship baggage tags and any personal ID in the form of a nametag to each piece of luggage before you leave home.

() Ensure that you hand carry all medication, proof of citizenship, travel documents, valuables and any other items that will meet your needs until your luggage is delivered to your stateroom.

() Familiarize yourself with a few ship policies noted within this booklet on the Ship Information page(s).

() Be prepared during ship check-in formalities to show qualifying proof of a restricted fare purchase (if applicable).

() Plan your ground transfers to and/or from the pier. Contact your travel agent or our reservations department at +1.800.437.3111 at least two (2) weeks prior to your cruise.

Travel Documents

Before leaving home, please take a few minutes to familiarize yourself with the required travel documents you will be asked to provide prior to boarding the ship. **Caution:** The requirements described below are required by government regulations and policies. They are subject to change without notice.

It is the sole responsibility of the guest to identify and obtain all required travel documents and have them available when necessary. These appropriate valid travel documents such as passports, visas, inoculation certificate and family legal documents are required for boarding and re-entry into the United States and other countries.

Guests who do not possess the proper documentation may be prevented from boarding their flight or ship or from entering a country and may be subject to fines. **No refunds will be given to individuals who fail to bring proper documentation.**

Consecutive Sailings

- Guests on consecutive sailings must ensure they have the proper travel documents for their cruise vacation.

Passport Requirements

The Western Hemisphere Travel Initiative (WHTI) once fully implemented will require all travelers entering or reentering the United States to be in the possession of a valid passport.

Anticipated Implementation

- January 23, 2007- Valid passport required for air travel to/ from Canada, Mexico the Caribbean and Bermuda.
- June 8, 2007 - The departments of State and Homeland Security relaxed the valid passport rule for air travel to Canada, Mexico, the Caribbean and Bermuda provided travelers can show (a) a government-issue photo identification and (b) a official proof of application for a U.S. passport from the U.S. Department of State which can be secured from <http://travel.state.gov>. Children under the age of 16 traveling with their parents or legal guardian will be permitted to travel with the child's proof of application.

Note: Travelers who have not applied for a passport should not expect to be accommodated.

- October 1, 2007 - The departments of State and Homeland Security reestablish the valid passport requirement for air travel to / from Canada, Mexico the Caribbean and Bermuda.

U.S. lawful permanent residents will continue to be able to use their Alien Registration Card (Form I-551) issued by the Department of Homeland Security or other valid evidence of permanent residence status to apply for entry to United States.

- January 1, 2008 - A valid passport will be required for all sea and travel. And subject to U.S. Government amendment, U.S. and Canada citizens 15 or younger with their parents consent may cross the U.S./Canadian border by land or sea with a certified copy of their birth certificate.

Until that time...

Sea Travel Only

- For domestic travel which includes: the Bahamas, Bermuda, Canada, the Caribbean and Mexico, a passport (valid or expired) is highly recommended.
- In the absence of a passport, a birth certificate (original or certified copy), plus laminated picture ID card issued by a federal, state, or local government agency is required. **Note:** Baptismal paper and hospital certificates of birth (except for new borns) are not acceptable.
- For U.S. Naturalized citizens, in the absence of a passport, Naturalization papers (either original or notarized copy) plus a picture ID card issued by a federal, state, or local government agency is required.
- A voter registration card or Social Security Card are not considered to be proof of citizenship.
- Children under 16 years of age do not require a picture ID.

International Travel

- A valid passport is required; visas are required where they apply. This includes Europe, Asia, Central and South America.

Our Recommendation

Celebrity Cruises strongly recommends that all guests travel with a valid passport during their cruise. This greatly assists guests who may need to fly out of the United States to meet their ship at the next available port should they miss their scheduled embarkation in a U.S. port; guests entering the U.S. at the end of their cruise; and guests needing to fly to the U.S. before their cruise ends, because of medical, family, personal or business emergencies, missing a ship's departure from a port of call, involuntary disembarkation from a ship due to misconduct, or other reasons.

Guests who need to fly to the United States before their cruise ends will likely experience significant delays and complications related to booking airline tickets and entering the United States if they do not have a valid U.S. passport with them.

Non-U.S. Citizens

You will need a valid passport and, in some cases, a visa. If you live in the U.S., you will also need the original copy of your Alien Registration Card (ARC or "Green Card") and any other documentation the countries on your itinerary require due to your alien status.

Take 836 East through the toll. Exit at US1 N.E. 2nd Avenue/Biscayne Boulevard, proceed straight through one light, and then turn right at the second light onto Biscayne Boulevard (US1). Stay in your left-hand lane and turn left into the Port of Miami on N.E. 5th Street. Drive across the bridge and follow signs to your pier terminal.

From: Fort Lauderdale International Airport
Take I-95 South to Exit 3B, N.W. 8th Street. Turn left onto 5th Street and continue straight until you reach the Port of Miami bridge. Drive across the bridge and follow signs to your pier terminal.

PIER LONG TERM PARKING: A parking garage is across the street from the pier terminal and takes Visa, MasterCard or cash. For parking information and RV restrictions please call +1.305.347.4933 or +1.305.347.4946.

Ship Information

Celebrity Cruises Guest Conduct Policy

On every Celebrity vessel, we are committed to providing every guest with a cruise vacation that is a touch above. To further ensure that you and your fellow guests receive exactly that, we have developed a set of Guest Conduct Policies that is available onboard and at celebritycruises.com. We thank you in advance for your compliance.

IMPORTANT: A violation of Celebrity's Guest Conduct Policy is cause for appropriate corrective action, including confiscation of improper materials or items and disembarkation of the guest from the vessel. The policy is subject to change without notice and without liability to Celebrity. Celebrity is free to adopt additional rules not stated in the policy.

Celebrity Cruises Alcoholic Beverage Policy

The minimum drinking age for all alcoholic beverages on all Celebrity ships is twenty-one (21) years of age.

> However on ships in Europe, South America and Australia, where the legal drinking age is lower than 21, a parent who is sailing with his or her son(s) and/or daughters(s) who is between the ages of 18 to 20, may sign a waiver allowing the 18 to 20 year old to consume alcoholic beverages.

> The 18 to 20 year old guest must agree to comply with Celebrity Cruises' policies, including among other things, agreeing to not provide alcoholic beverages to any other person, regardless of age. Restrictions apply and this policy is subject to change without notice.

An individual's age on the date of sailing determines his/her status for the entire cruise vacation

Guests are not allowed to bring beer or hard liquor on board for consumption or any other use. Guest wishing to bring personal wine onboard with them at the beginning of a cruise may do so, limited to two (2) bottles per stateroom, but when consumed in any shipboard restaurant, bar or dining venue, each bottle shall be subject to a corkage fee of \$25.00. If the guest receives a bottle of wine (in their stateroom) from a family member or friend, and that bottle(s) was purchased from our Bon Voyage Gift selection, then no corkage fee will apply if they wish to consume the bottle in the dining room or any other public area. If the guest receives a bottle from an outside vendor and/or travel agent, and the bottle was not purchased through our Bon Voyage selection, then a \$25.00 corkage fee per bottle will apply if they wish to consume the wine in the dining room or any other public area. The fee will be applied to the guest's on board account.

Alcoholic beverages that are purchased in the ports of call or from on board shops will be stored by the ship and delivered to guest stateroom on the last day of the sailing. **Security may inspect containers (water bottle, soda bottles, mouthwash, luggage etc.) and will dispose of containers holding alcohol.** Celebrity Cruises' Guest Conduct Policy may be enforced, up to and **including disembarkation, if a guest violates and alcohol policy.** Guests under the age of 21 will not have alcohol returned to them.

Guests who violate any alcohol policies (over consume, provide alcohol to people under age 21, demonstrate irresponsible behavior, or attempt to conceal alcoholic items at security and or luggage check points or any other time), **may be disembarked or not allowed to board, at their own expense**, in accordance with our Guest Conduct Policy.

Celebrity Cruises reserves the right to revoke or otherwise restrict drinking privileges any guest, regardless of age. Even if all criteria are met, shipboard personnel may elect, and have the option to not grant the waiver or any such drinking privileges. The waiver may not apply when the vessel is in certain territorial waters.

Shore Excursion Information

The tour descriptions contained in this booklet may be abbreviated.

In order to view full descriptions please visit our Internet Shore Excursion System at www.celebrity.com. and select the "Plan Your Cruise" option. Use the drop-down menu and click on the "Shore and Land Excursion" link. Once in our website you can review all tour details or print a brochure with complete shore excursion descriptions if you so desire.

Shore Excursions can also be purchased online.

For your convenience it is now possible to pre-book your shore excursion(s) up to 10 days prior to your sailing date by visiting www.celebrity.com. To book an excursion, you will need your cruise Reservation ID, ship name, and sailing date. Once you have completed your purchase, an immediate recap of the selected tours will be offered. A final e-mail confirmation will also be delivered to your e-mail address once your credit card is approved.

Within 10-days prior of your sailing date, the Internet system is closed and no further shore excursion pre-sales are possible. At this point, any additional shore excursions you may wish to purchase are available only onboard the ship on a first-come first-served basis.

Once onboard, shore excursion booking forms can be found in your stateroom or at the shore excursion desk.

Some of our ships offer an interactive system, which also allows you to book shore excursion(s) from the convenience of your stateroom TV. This system is very user friendly and will book and debit shore excursion(s) through your onboard charge account.

Confirmation of any tour(s) pre-purchased prior to the production of this ticket booklet is enclosed.

All shore excursion ticket(s) pre-booked or purchased onboard will be delivered to your stateroom.

General Information

Introduction

This brochure contains brief descriptions of tours available. Please book your excursions as soon as possible since certain shore excursions can accommodate only a limited number of participants. We recommend that you purchase them in advance of your cruise in order to avoid disappointment.

Restrictions

Please note there are certain excursions that for safety reasons, age, weight and/or height restrictions apply. These restrictions are imposed by the individual vendor and Celebrity Cruises, Inc. must comply accordingly.

Tour Availability

Please note that not all tours are available on all ships. Tour prices and itineraries are in effect at the time of printing and are subject to change without notice.

Weather

Most tours will operate rain or shine. However, full refunds will be made to guests holding tickets for canceled shore excursions. In the event of a tour cancellation, every effort will be made to accommodate guests on other available tours.

Children's Pricing

Unless indicated, children's pricing is valid for children 12 and under. Guests under 18 years of age must be accompanied by a parent or guardian.

What To Know

SHORE EXCURSION OFFICE: Desk hours will be announced on board in the ship's Daily Program. Normally, the office will be closed while the vessel is in port, unless otherwise stated.

TIMES OF TOURS COMMENCEMENT will be published on board. In the interest of all concerned, please be punctual to the meeting points. Guests wishing to travel with friends should proceed to the point of departure as indicated on your shore excursion tickets, as this will help the tour staff to allocate space in the same vehicle.

EXCURSION TIMINGS: Most morning tours will meet in a lounge onboard the ship. When the ship is at anchor, staff will be on hand to assist you to the departure point. Timings have been established according to information received from our Agents but are subject to alterations should the vessels arrival time at the port be delayed or circumstances arise whereby the itinerary for a particular excursion must, necessarily, be amended. Kindly note that tour times provided online may be earlier than the vessel's scheduled arrival to a port of call. The time listed may be in local time as provided by the tour operator. The most accurate tour departure time will be provided directly onboard the vessel. When the ship lies at anchor, guests should allow ample time for the tender ride to shore. When booking more than one tour in a day, please allow at least 60 minutes between the return of the first tour and the departure of the second tour. Tour departure times may vary from those listed on the order form, especially in ports where the ship must tender guests ashore. Please check your tour tickets for the time and location of departure. No announcements for the tours will be made onboard the ship. All guests are required to be back aboard ship no later than 30 minutes prior to the scheduled departure time, which is listed in the Daily Program and posted at the gangway. The scheduling of all Shore Excursions conforms to this requirement. If you leave a

tour en route, it will be your responsibility to secure transportation and return to the pier on time. If for any reason a ship's excursion is delayed in its return to the pier, the ship will be notified and will await the tour's return.

JOINING EXCURSIONS: Please show your excursion ticket when coming ashore and boarding the excursion vehicle.

SEATS are not reserved in advance. This procedure aids the rapid departure of excursions.

PRICES of shore excursions are quoted per person and generally include available local transportation, ranging from coaches, taxis, limousines, and boats. Meals and local taxes are included where specified. Where tours are operated by car, 2 to 3 persons are allocated to each vehicle.

WITHDRAWAL OF TOURS: The right is reserved to withdraw any tour, to limit membership in any tour, or to make alterations in the operation of any tour, which may be deemed advisable for the safety or convenience of guests.

ITINERARIES are expected to be operated as described in the brochure but the right is reserved to change or omit a place to be visited or the sequence of the tour, in accordance with conditions or circumstances prevailing at the time of tours, with or without previous notice; bearing in mind the convenience and best interest and safety of guests. The right is also reserved to decline, to accept, or retain any person as a member of any party at any time.

RESERVATIONS/CANCELLATIONS: Shore Excursions are available for purchase once you are aboard the ship and en route to your destinations except where otherwise noted, within the deadline advertised in the ship's daily program. Very shortly after each closing time and date, final confirmations are sent from the ship to the Agencies concerned informing them of the definite and final requirements for meals, seats, number of automobiles and coaches, etc. If notice of cancellation is received after closing date and hour, a refund can be assured only in the event of the ticket being resold. However, in the event of any of the shore excursions having to be canceled, full refund will be made and upon tendering of same Celebrity Cruises shall be free of all liability in respect thereof. The closing dates and hours for all tours will be announced in the daily issue of the ship's program.

REFUNDS: No refunds are made to any guest who might cancel, deviate, leave, or otherwise not utilize all of the services scheduled to be provided by an excursion. Members of any excursion who elect to leave the automobiles or coaches, in the shopping area, or elsewhere, must provide their own transportation at their expense back to the landing place of the vessel. Should any such excursion, however, be abandoned through force majeure the best possible refunds will be arranged according to the circumstances. Any refund request of prepaid excursions received by Celebrity Cruises 10 days prior to sailing will be made in full. Refund requests made onboard after the Shore Excursion Office closes ticket sales for that particular port will not be accommodated.

TOURS PURCHASED ONBOARD will be charged to your Celebrity Signature Account Card.

GUIDE SERVICES AND TRANSPORTATION EQUIPMENT: In certain interesting but off the beaten track places, professional guides are at a premium. The best available and obtainable guides of competence are engaged. It is exceptional for drivers of public hire vehicles to speak any language but their own. Transportation equipment used for the shore excursions is the best available in the ports of call. Air-conditioned vehicles are not always available nor do all tour buses have restroom facilities onboard.

ENTRANCE FEES: Entrance fees to all museums and sites are included in the price of the respective shore excursions unless otherwise stated. Occasionally, a small extra charge is levied if photographs are taken, and this is not included.

TIPS: Tipping of any service personnel encountered on any of the shore programs is strictly optional.

MEALS: Most tour departure times complement the ship's meal service hours, so you can enjoy your meal aboard and then go ashore. However, if you take more than one tour in a day, your return on board may not coincide with meal hours. You'll be informed of meal times before arrival in each port. Full day tours include meals where indicated.

ALTERATION OF FARES, TRANSPORTATION SERVICES, ETC.: All prices quoted are based on tariffs and exchange rates current at the time of printing, and are subject to increase with or without previous notice consequent upon any increase in the basic tariffs and/or exchange fluctuations, which may accrue prior to commencement of the tours.

NIGHT EXCURSIONS vary throughout the worlds cruise ports. Many hotels have international-type acts, others national dances or folklore shows. Some ports are renowned for nightlife, while others are more conservative. We aim to take you to the most generally accepted shows for the region. Check the charges before ordering extra refreshments, photographing, or recording.

DRESS WHILE ASHORE: The local authorities and inhabitants of the countries visited have more conservative ideas concerning dress than you may be accustomed. So as not to offend local opinion, we would suggest that you should dress conservatively.

Activity Level

The Shore Excursions presented in this brochure require the guest to use a motor coach or other forms of transfer which will require the guest to step up 2 to 3 steps, approximately 10 inches high each. Most (but not all) coaches used can accommodate collapsible wheelchairs. Mild



To fully participate may require leisurely walking over primarily even surfaces. There may be a limited number of steps, a minimal amount of cobblestones or uneven surfaces, and some standing for extended periods of time.

Moderate



To fully participate may require extended periods of walking over even and uneven surfaces, steep terrain and/or water activity in a slight current. There may be steps, inclines, cobblestone surfaces, and extended periods of standing. Participants with physical limitations should take this into account.

Strenuous



To fully participate may require extended periods of physical exertion, extensive walking, climbing, or biking. There may be numerous steps, inclines, cobblestones, and other rough terrain throughout the excursion. These excursions are the most active and have been designed for participants in excellent health and very good physical condition.

Dress Code



Conservative attire is recommended when going ashore on this tour. No exposed shoulders or knees. Short pants and tank tops are not acceptable.

Important - Passenger Cruise/CruiseTour Ticket Contract 1

Read All Clauses

Whether or not signed by Passenger, this ticket shall be deemed to be an undertaking and acknowledgement by Passenger that he accepts on behalf of himself and all other persons traveling under this ticket, all the terms and conditions set out herein.

1. (a) "Passenger" includes all persons traveling under this ticket and their heirs and representatives. "Passenger" shall include the plural and the use of the masculine shall include the feminine.

(b) "Carrier" means the cruise line operator named in Article 20 of this Cruise Ticket Contract, all Vessels, Royal Celebrity Tours Inc. ("RCT") with respect to the RCT Land Tour portion of any CruiseTour, and their respective employees, agents, affiliates, successors and assigns.

(c) "Vessel" means the ship chartered by Carrier on which Passenger may be traveling or against which Passenger may assert a claim.

(d) "CruiseTour" shall mean the combined vacation package consisting of the cruise described in this booklet and the RCT Land Tour.

(e) "RCT Land Tour" shall mean the land tour component of a CruiseTour to be provided either prior to the initial embarkation on the cruise or after the final debarkation from the cruise, as indicated in this booklet.

(f) "Transport" means the railcars, buses and other modes of transportation or accommodation provided by RCT in connection with a RCT Land Tour.

2. (a) Each adult Passenger is permitted to carry up to two hundred pounds (200 lbs.) of luggage aboard the Vessel. In no event shall any Passenger bring on board the Vessel, or in connection with the RCT Land Tour, any controlled substances, live animals, weapons, firearms, explosives or other similar property without written permission from Carrier. Carrier reserves the right to refuse to permit any Passenger to take on board the Vessel or on any mode of Transport any item Carrier deems inappropriate.

Carrier's liability for loss of or damage to valuables so deposited shall not exceed the amounts indicated in Clause 2(c).

3. No undertaking or warranty shall be given or shall be implied as to the seaworthiness, fitness or condition of the Vessel or any food or drink supplied on board.

4. Any medical personnel, masseuse, hair stylist, manicurist or other service providers on board the Vessel or on Transport are provided solely for the convenience of Passenger. Such persons are independent contractors and not acting as agents or representatives of Carrier. Carrier assumes no liability whatsoever for any treatment, diagnosis, advice, examination or other services provided by such persons. Passenger shall pay for all medical care requested or required, whether aboard or ashore, including the cost of any emergency medical care or transportation incurred by Carrier.

5. All arrangements made for or by Passenger for air transportation, shore excursions, ground tours, ground transportation, hotels, restaurants and other similar activities or services are made solely for Passenger's convenience and are at Passenger's risk. The providers of such services are independent contractors and are not acting as agents or representatives of Carrier. 6. Carrier may for any reason, at any time and without prior notice, cancel, advance, postpone or deviate from any scheduled sailing or port of call, or substitute another vessel or port of call, and shall not be liable for any loss whatsoever to Passenger by reason of such cancellation, advancement, postponement, substitution or deviation. 8. Refunds for Passenger cancellations prior to sailing or the first day of the Cruise Tour (whichever occurs first) are limited by the terms of Carrier's refund policy. Passengers are advised to consult the Carrier's cruise brochure for the terms of Carrier's refund policy.

9. All Passports, visas and other travel documents required for embarkation and disembarkation and at all ports of call are the responsibility of Passenger.

10. Passenger, or if a minor, his parent or guardian, shall be liable to, and shall reimburse Carrier for, any damage to the Vessel, the Transport or any property of Carrier caused directly or indirectly, in whole or in part, by any willful or negligent act or omission on the part of the Passenger; and Passenger, or if a minor, his parent or guardian, shall further indemnify Carrier, the Vessel and the Transport and each and all of their agents and servants against all liability which Carrier, the Vessel or the Transport or such agents or servants may incur towards any person or company or government for any personal injury, death or damage to property caused directly or indirectly, in whole or in part, by any willful or negligent act or omission on the part of Passenger.

11. IT IS AGREED BY AND BETWEEN PASSENGER AND CARRIER THAT ALL DISPUTES AND MATTERS WHATSOEVER ARISING UNDER, IN CONNECTION WITH OR INCIDENT TO THIS CONTRACT SHALL BE LITIGATED, IF AT ALL, IN AND BEFORE A COURT LOCATED IN MIAMI, FLORIDA, U.S.A., TO THE EXCLUSION OF THE COURTS OF ANY OTHER STATE, TERRITORY OR COUNTRY. PASSENGER HEREBY WAIVES ANY VENUE OR OTHER OBJECTION THAT HE MAY HAVE TO ANY SUCH ACTION OR PROCEEDING BEING BROUGHT IN ANY COURT LOCATED IN MIAMI, FLORIDA.

12. (A) NO SUIT SHALL BE MAINTAINABLE AGAINST CARRIER, THE VESSEL OR THE TRANSPORT UPON ANY CLAIM RELATING TO LOSS OF OR DAMAGE TO PROPERTY UNLESS WRITTEN NOTICE OF THE CLAIM, WITH FULL PARTICULARS, SHALL BE DELIVERED TO CARRIER AT ITS PRINCIPAL OFFICE WITHIN TEN (10) DAYS AFTER TERMINATION OF THE VOYAGE OR THE CRUISE TOUR (WHICHEVER IS LATER) WHICH THIS CONTRACT RELATES; AND IN NO EVENT SHALL ANY SUCH SUIT FOR ANY CAUSE AGAINST CARRIER, THE VESSEL OR THE TRANSPORT RELATING TO LOSS OF OR DAMAGE TO PROPERTY BE MAINTAINABLE UNLESS SUCH SUIT SHALL BE COMMENCED (FILED) WITHIN SIX (6) MONTHS AFTER THE TERMINATION OF THE VOYAGE OR THE CRUISE TOUR (WHICHEVER IS LATER) AND PROCESS SERVED WITHIN THIRTY (30) DAYS AFTER FILING, NOTWITHSTANDING ANY PROVISION OF LAW OF ANY STATE OR COUNTRY TO THE CONTRARY.

In addition to the restrictions and exemptions from liability provided in this Contract, Carrier shall have the full benefit of any applicable laws providing for limitation and exoneration from liability, and nothing in this Contract is intended to operate to limit or deprive Carrier of any such statutory limitation of or exoneration from liability. Without limiting the foregoing, Carrier claims benefit of all restrictions, exemptions and limitations of the "Convention Relating to the Carriage of Passengers and Their Luggage by Sea" of 1974 as well as the Protocol to the "Convention Relating to the Carriage of Passengers and Their Luggage by Sea" of 1976 ("Athens Convention"), which limits the liability of the Carrier for the death of or personal injury to a passenger to no more than the applicable amount of Special Drawing Rights as defined therein, and all other limits on damage or loss to personal property.

19. This Contract contains the entire agreement between Carrier and Passenger and supersedes any other agreements, written or oral, relating to the subject matter. Any waiver of any provision of this Contract must be made in writing and signed by Carrier. If any portion of this Contract shall be determined to be invalid, then said portion shall be deemed severed from the Contract in such jurisdiction only and all remaining portions shall remain in full force and effect.

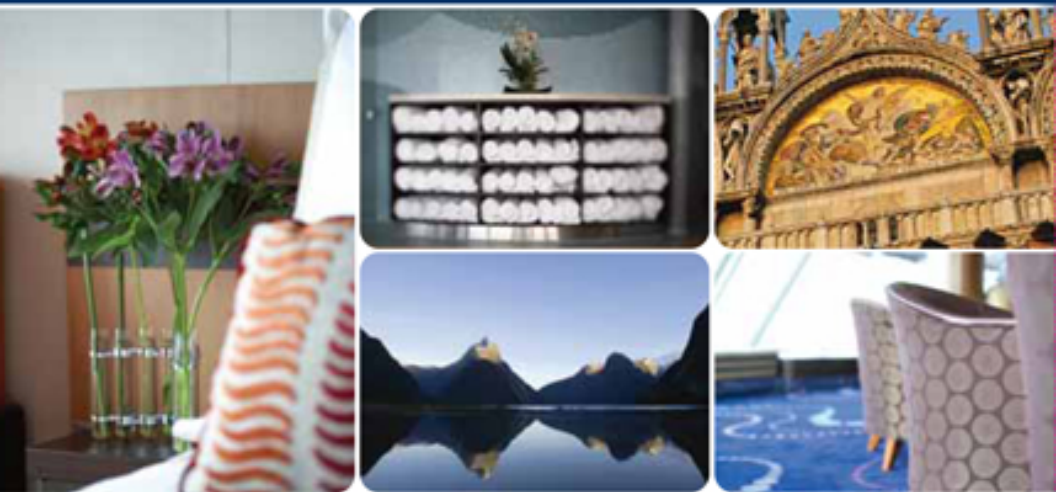
