

Evolution moves at its own pace in the Galapagos. Make a pact to do the same.

600 miles off the western coast of Ecuador lies a group of islands so isolated that many of its creatures cannot be found anywhere else on earth. Welcome to the Galapagos, the inspiration for Charles Darwin's theory of evolution.

On his 1835 expedition, Darwin found a cluster of islands formed four to five million years ago when underwater volcanoes erupted in the Pacific Ocean. Today, these rock outcroppings, rivers of frozen lava,

and coral beaches form a varied landscape that's home to the islands' collection of rare birds and animals.

In his journal, Darwin noted, "These islands seem to be a little world within themselves – a perennial source of new things." It boggles the mind to think that the "new things" Darwin saw – the marine iguanas, flightless cormorants, and giant tortoises – are the very same species you can see today over 150 years later.

### Isla Baltra

This island houses the main airport of the Galapagos and is where your unforgettable journey begins.

### Isla North Seymour

Off the northern tip of Baltra is this flat, lowlying island where blue-footed boobies nest, sea lions play and the largest colony of frigate birds in the Galapagos congregates.

### Isla Española

Welcome to the only place where the waved albatross nests. With rocky outcroppings, sea cliffs and a blowhole that spews water up to 75 feet in the air when the surf rushes in, Española belongs on your "don't miss" list.

### Isla Santa Cruz (Darwin Station)

Located on Isla Santa Cruz are the headquarters of the Charles Darwin Research Station. Make time to visit the Rearing Center for giant tortoises, and learn more about island conservation and ongoing research.

### Isla Santa Cruz (Cerro Dragon)

Also known as Dragon Hill, this area is nestled on the north shore of Santa Cruz Island.

Covered by mangroves, it shelters one of the few populations of land iguanas on earth.

#### Isla Bartolomé

With its moon-like surface, you'll feel like you're in another world. Be sure to trek over the island's lava tubes and tuff cones, and take in the views from the famed Pinnacle Rock.

#### Las Bachas

This white-sand beach on the island of Santa Cruz is a major egg-laying site for Pacific green turtles, but pelicans and flamingos feel equally at home here, too.

### Isla Isabela (Caleta Tagus)

Caleta Tagus is the trail that surrounds a saltlake crater. But it's just one of the highlights of your visit to Isla Isabela. Others include Darwin's finches, seabirds, and a 5,600-foot volcano.

### Isla Fernandina

In the center of this island is La Cumbre Volcano, whose recent eruption has left lava flows you can walk right over. Fernandina's also a hot spot for endemic flightless cormorants and the largest colony of marine iguanas.

### Isla Santiago (Puerto Egas)

Follow Puerto Egas, a coastal trail on Isla Santiago, and your rewards will be many: fur sea lions, Sally Lightfoot crabs and grottos made from black lava.

#### Isla Rábida


Formed from oxidized lava, Rábida's beaches have an unmistakable red color. Adding to the color of the island is its collection of sea lions, flamingos and palo santo trees.

#### Isla Santa Maria (Floreana)

Bring your postcards with you to a special spot on this island called Post Office Bay. It's the historical site where an 18th-century whaling crew placed the wooden barrel that tourists still use today as a post office.

### Quito

With each new vantage point better than the last, there's no shortage of sights to see in the capital of Ecuador. Start with the Andes Mountains or the café-lined streets of New Town.




























#### Passenger Ticket Contract

The transportation of guests and baggage on Celebrity Xpedition™ is governed by the terms and conditions of the Cruise Ticket Contract included as part of the cruise documentation. The Cruise Ticket Contract, which is between the carrier IGTV and you, limits your rights against both IGTV and Celebrity. Among other things, the Cruise Ticket Contract sets forth limitations on the time frames in which claims may be made and suits filled against IGTV or Celebrity. It is important that you read all of the terms and conditions of the Cruise Ticket Contract, paying particular attention to sections 11 and 12.

NOTE: A Cruise Ticket Contract must be signed by each guest prior to boarding. (Copies are available upon request and may be available online at www.celebrity.com.)

The terms and conditions set forth in this brochure shall also apply. Any and all information contained in this brochure, including prices, and terms and conditions, is subject to change at any time without notice. In the event of any conflict between (on the one hand) the terms and conditions of this brochure, any advertisements or offers related to a Celebrity Xpeditions "voyage, or any oral or written representation of any IGTV or Celebrity representative and (on the other hand) the Cruise Ticket Contract, the terms of the Cruise Ticket Contract, shall govern.

We are not responsible for any failure by your travel agent to remit your deposits or payments to us and you shall remain liable to us for any portion of the voyage or related fares that we did not receive. Similarly, we are not

responsible for any failure by your travel agent to remit a refund from us to you.

#### Deposits and Payments

The minimum initial deposit required per person is U.S.\$450.00 for double occupancy staterooms. The minimum initial deposit for single staterooms or triple or quad staterooms shall vary as we determine. The minimum deposit amount must be received by us within seven (7) days of the booking.

inal payment must be received at Celebrity's ffices at least ninety (90) days prior to the alling date for the voyage.

If you booked your voyage through your travel agency, you may pay us directly via credit card or provide payment to your travel agents. #### Cancellations

Cancellations must by made by the guest or his/her travel agent. Depending on when the voyage is cancelled, a cancellation charge may apply. See the chart below for applicable late cancellation charges for voyages. Consult your travel agent for late cancellation charges applicable to single, triple/quad, holiday sailings and group bookings.

We are not responsible for any payments you made to your travel agent that we did not receive nor any refunds that we provided to your travel agent.

Travel agents may impose their own service charges in connection with a voyage. Any such charges are a matter strictly between you and your travel agent.

#### Pre/Post Packages

From time to time either of us may make arrangements for excursions and tours that are available in Ecuador prior to or after your voyage. All such excursions or tours are operated by independent contractors and we act only as an agent in booking them and shall not be responsible for any loss, injury or death arising out of any service provided. These independent contractors may impose additional limitations of liability or terms

#### Optional Air Arrangements

If you booked a 10 or 11-night voyage, you can also make your arrangements for air transportation to/from Ecuador with Celebrity. When you purchase Air Arrangements in

connection with a 10 or 11-night voyage through Celebrity Cruises, you can expect the following:

- Round-trip air transportation to and from the Quito Airport.
- In most cases, no more than one connection from your gateway city in the United States or Canada
- E-tickets are available for your convenience for selected carriers.
- The ability to upgrade your transportation arrangements (for an additional fee).
- The ability to book your preferred schedule and/or airline
- Delivery of tickets to your travel agency.
- Locking in or changing assigned flight itineraries prior to cruise departure.

Should you choose to make your own airtransportation arrangements, we will not be responsible for any hotel arrangements nor will *Celebrity Xpedition*<sup>™</sup> be able to welcome you earlier than the scheduled boarding time.

### What You Need to Know Before You Go

#### Visiting the Islands

The mean temperature in the Galapagos stays relatively constant, with average highs and lows ranging from 73 to 81 degrees

December through May, and 70 to 78 degrees June through November.

## Advanced or Delayed Sailing/Itinerary Change

In the event of strikes, lockouts, riots, weather conditions, mechanical difficulties or for any other reason whatsoever, Celebrity may, at any time and without prior notice, cancel, advance, postpone or deviate from any scheduled sailing or port of call and may, but is not obliged to, substitute another vessel or port of call, and shall not be liable for any loss whatsoever to guests by reason of such cancellation, advancement, postponement, deviation or substitution. Celebrity shall not be responsible for any failure to adhere to the

arrival and departure times published in this brochure for any of its ports of call.

While every effort will be made to adhere to the specifics shown herein for a cruise, circumstances may necessitate changes or deviations there from. All schedules, itinerary destinations, hours of arrival and departure, hotel and/or conveyances, and other aspects of cruise programs are subject to change without prior notice. Neither Celebrity nor any affiliated party shall be required to refund any portion of fare or other charges or make any compensation under these circumstances.

#### Age Restrictions

Guests under the age of 21 must be booked in a stateroom with an adult who is 25 years or older. A parent or legal guardian must accompany guests under the age of 18 and must be booked in the same stateroom. Acceptable proof may be required. These age restrictions will be waived for minor children salling with their parents or guardians in adjacent staterooms.

#### Alcoholic Beverages

No alcoholic beverages will be served to any guest under 21 years of age. The parent or legal guardian of a guest who is between 18 and 20 years of age may sign a waiver permitting such guest to be served beer or wine while in international waters. In port, the minimum drinking age is 21. No alcoholic beverages may be brought on board for consumption.

#### Baggage

The air carriers flying between Quito and Baltra typically limit the amount of luggage per guest to one checked piece, not to exceed 30/lbs. and a small carry-on bag. Guests may bring a reasonable amount of clothing and personal effects on board Celebrity Xpedition. However, for guests' comfort and convenience, it is recommended that they limit the number of items they take

#### Boarding

From the flight from Quito, you will be transferred directly to the pier in Baltra where you will be tendered out to *Celebrity Xpedition*. Boarding begins at approximately 2:00 in the afternoon. Please check with your travel agent to confirm departure times. Customers who booked the 7-night voyage package must arrive for check-in at least 60 minutes before the vessel's scheduled departure time; failure to do so will constitute a no-show and result in the cancellation of your booking and the imposition of a cancellation charge.

#### Change of Stateroom

Guests desiring to transfer to a higher-priced accommodation, which may be available during boarding or after sailing, may do so by paying, in cash, traveler's checks, Celebrity, Signature Account or by credit card, the difference in published full cruise prices.

#### Clothina

Guests will need two types of clothing on their Celebrity cruise: Casual Explorers Day Wear and Casual Evening Wear.

#### Casual Explorers Day Wear

Lightweight, comfortable clothing suited for walking/hiking. This includes:

- Lightweight or cotton pants and shorts
- Lightweight short-sleeved and long-sleeved shirts such as polo shirts and cotton T-shirts, lightweight rain jacket/wind breaker, and sweatshirt.
- Comfortable walking shoes or lightweigh hiking boots, and waterproof sandals for wet landings.
- Two or more bathing suits, as well as extra sunblock, sun hats, sunglasses and other types of sun protection.

#### Casual Evening Wear

- Casual dress or skirt
- Blouse or pants outfit.
- Sweaters, jackets/windbreakers should be packed.

For men this includes

- Slacks or pants

- Polo-type or button-down shirts.

#### Communications

Telephone service is available, at a reasonable fee, in each stateroom on board Celebrity Xpedition. Details about contacting the ship will be provided in the Guest Ticket Booklet.

#### Cruise Documents

## Passports, Visas and Other Required Documentation

You are responsible for bringing all travel documents, such as passports, visas, proof of citizenship and proof of mandatory inoculations, required for boarding the vessel in Ecuador and for entry or re-entry into any countries through which your voyage or other travel arrangements take you. At a minimum, each guest will need a valid passport. Consult your travel agent for additional travel requirements.

NOTE: The expiration date of your passport must not occur within six months of the scheduled termination date of your yoyage.

When evaluating what travel documents you need, bear in mind that if you travel through other countries before embarking on the vessel or after disembarking from the vessel, additional travel documentation requirements may apply. Give yourself plenty of time to obtain or renew your passport or other needed forms of identification and all other travel documents.

Governmental rules and regulations are constantly evolving and you may be required to provide certain personal and other details. In order to make your boarding process as simple as possible, we may offer an online method of providing some or all of this information. Visit celebrity.com to use our online information tool. Guests who do not provide information online will have the necessary forms sent to them with their cruise documents. Please fill these forms out prior to arrival at the vessel. If you fail to supply the details required fully and accurately, you may not be permitted to board the vessel or your flight. If, as a result of your failure to comply with the foregoing, Celebrity incurs any fines, surcharges or other financial penalty, you will be responsible for reimbursing Celebrity

## 2. Why Is Having the Right Documentation Important?

Guests who do not have the proper documentation may be prevented from boarding the vessel and/or their flight or from disembarking or entering a country, and may be subject to fine and other punishments. If, as a result of your lack of proper documentation, a fine or other cost is incurred by us, you agree to indemnify each of us for such expenses. It is the sole responsibility of the guest to identify all travel, inoculation and health requirements and obtain and have available when necessary the appropriate and valid travel documents, such as passports and visas, inoculation documents, such as Yellow Fever certificates, and other health requirements.

NOTE: No refunds will be given to individuals who fail to bring proper documentation.

Please check with a travel agent, government agencies, embassies, consulates, your physician, local health departments, the Centers for Disease Control and Prevention (www. cdc.gov), or the Department of State General Visa Information at (202) 663-1225 to determine travel and health documentary requirements.

We reserve the right to restrict the ability of guests under the age of 16 to go ashore unaccompanied by a consenting parent, guardian or other responsible adult.

#### 3. Embarkation Forms

In order to make your boarding process as simple as possible, we offer an online method of providing information we need before you can embark on the vessel. Just visit celebrity.com to fill out your embarkation forms. For guests who do not provide the information online, embarkation forms will be automatically included with your cruise documents. Please fill out these forms before you leave

#### 4. Travel Documentation

Guest cruise documents provide information relevant to the sailing. Normally, documents will be received by the travel agent 20 to 50 days prior to the sailing date, assuming voyage elements are finalized and all payments have been made and received by us. Group and Air/Sea documents require additional

steps and will normally be received by the travel agent inside of 30 days of sailing.

#### Customs

Detailed instructions about clearing customs will be provided by our onboard staff prior to your disembarkation from the voyage. We highly recommend that you attend this important and informative talk.

#### Guest Behavior Policy

IMPORTANT: A violation of the Guest Behavior Policies is cause for appropriate corrective action, including confiscation of improper materials or items and disembarkation of the guest from the vessel. These policies are subject to change without notice and without liability to us. We are free to adopt additional rules not stated in those policies.

#### Health

#### General Health Requirements

All guests must ensure that they are medically and physically fit for travel and that such traveling will not endanger themselves or others. Guests with special needs should be self-sufficient, and Celebrity recommends that they travel with a companion to provide any required assistance. Guests with medical concerns are advised to check with their physician before sailing. Tendering may preclude guests from going ashore at certain ports of call and the terrain may also limit guests' ability to take certain land tours.

#### Smoking Policy

For the comfort of all of our guests, smoking is permitted on only the ship's outer decks and there only in designated smoking areas. As a courtesy to our guests, ship personnel will thoroughly enforce the smoking policy. Smoking is not permitted on the Zodiac rafts or other transport vessels.

#### Medical Conditions and Services

Celebrity Xpedition currently does not offer any staterooms that will accommodate wheelchairs or facilities needed by guests who are dependent on oxygen or requiring oxygen therapy.

#### Onboard Physicians

Each Celebrity vessel is equipped with a medical facility. One licensed (under Ecuadorian law) physician is normally in attendance on board. The medical services available on board and medications kept on board are extremely limited, and guests must bring an adequate supply of any specific medications they need. The medical facility is not intended or designed to serve as a clinic for guests and the use of those facilities (including any medications obtained therefrom) will result in a charge to the guest. We are not responsible for the diagnosis, treatment or services furnished by shipboard medical personnel, who are independent contractors. For further assistance, please contact the Special Services Department at 1-800-242-6374 with any questions.

#### Pregnancy

We welcome pregnant guests but will not accept guests who have entered their third trimester (27th week) of pregnancy by the beginning of, or at any time during, their cruise vacation

#### Special Dietary Requirements

Celebrity can accommodate the following special diets on board: vegetarian, diabetic, low-fat, low-sodium and low-cholesterol. Dietary requests need to be made in writing to our Special Services Department (fax requests to 1-800-882-8292 or e-mail celebrityspecialservices@celebrity.com) no later than 60 days prior to sailing.

#### Insurance

Because our liability for loss or damage is limited by the Cruise Ticket Contract, we recommend that all guests check their own insurance coverage before departure. For greater peace of mind, we offer the Celebrity Xpeditions<sup>11</sup> CruiseCare<sup>12</sup> Vacation Protection Plan, which offers affordable medical, travel and baggage coverage for the duration of your package vacation.

#### Naturalist-Guided Tours

The Celebrity Xpeditions Galapagos package includes daily tours accompanied by our naturalist guides to help you make the most out of your Galapagos visit. These guides also assist in Galapagos conservation efforts and must accompany all landing parties to the Islands. The naturalists will also be on board to provide lectures and briefings about upcoming attractions

#### Onboard Purchases

Celebrity Xpedition operates on a "cashless" system. Validate your Signature Account with your Visa, MasterCard, NOVUS or American Express Card or sign for payment by cash or traveler's check. Then you can sign all onboard services and purchases to your account. At the end of your cruise, you'll receive a completely itemized statement. (Sorry, we cannot accept personal checks and only U.S. currency is accepted aboard Celebrity Xpedition. If you choose to settle your account with cash, a deposit may be required in advance.)

#### Personal Property

Under no circumstances may dangerous articles, such as controlled substances, firearms, explosives or cylinders containing compressed air or combustible substances, etc., be contained in any baggage or brough by any person on board. We reserve the right or efuse to permit any guest to take on board any items we deem inappropriate. No animals are permitted on board (with the exception of service animals for guests with special needs).

Property lost or damaged should be reported to either the Guest Relations Desk or a designated IGTV employee prior to leaving the Ecuadorian Customs area on Baltra. In any event, property lost or damaged must be reported within the time limitations and in accordance with the procedures set forth in the Cruise Ticket Contract. In the absence of negligence on our part, we are not responsible for any loss, theft, pilferage and/or damage to a guest's property, which includes items such as money, travel currency, jewelry of any kind, photographic/electronic equipment or other personal property. Collectively, our liability is limited to \$300 (U.S. dollars) per guest and otherwise in accordance with the provisions in the Cruise Ticket Contract. Safes are available in every stateroom. #### Refusal of Passage

Passage may be refused to any guest, and any guest's cruise may be terminated at any time, at the risk and expense of the departing guest, where, in the opinion of the ship's captain or physician, a guest is unfit for travel or a risk or danger to himself or herself or a disturbance or danger to others. Such guest may be left at any port or place at which the ship calls without any liability to Celebrity. Celebrity shall not be required to refund any amount paid by any guest who must leave the cruise prematurely for any of the reasons set forth above or otherwise, nor shall Celebrity be responsible for lodging, meals, return transportation or other expenses incurred by the guest.

Any dispute between a guest and Celebrity in connection with a guest's cruise booking or cruise shall be litigated, if at all, in and before a court located in Miami, Florida, U.S., to the exclusion of the courts of any other state, territory or country.

#### Important Notice About Safety

At any given moment, there may be trouble spots in the world in terms of crime, war, terrorism or other risks. We endeavor to provide reasonable protection for your comfort and safety on board Celebrity Xpedition. However, we cannot guarantee freedom from all risks associated with crime, war, terrorism or other risks. Government agencies in a number of countries, such as the U.S. Department of State, regularly issue advisories and warnings to travelers regarding certain destinations.

We strongly recommend that guests and their travel agents obtain and consider such information when making travel decisions.

#### Carrier Liability

Guests release IGTV and Celebrity from any and all claims for loss or damage to baggage or property, or for personal injuries or death, or for loss from delay, arising out of the acts, emissions or negligence of any independent contractors, such as air carriers, hotels, shore excursion providers, restaurateurs, transportation providers, medical personnel or other providers of services or facilities. Under no circumstance does IGTV's responsibility extend beyond the vessel. All arrange-

ments made for the guest with independent contractors are made solely for the convenience of the guest and are at the guest's ris IGTV disclaims all liability for damages for emotional distress, mental suffering or psychological injury of any kind, under any circumstances, except to the extent such disclaimer is prohibited by 46U.S.C. 183c (b).
